Respected Sir,

This is to intimate you a general body meeting of the executives of Patna Telephones was conducted on 25th June'15 in the Telephone Patna and detailed discussion held regarding service related issues of PTD Patna. The meeting was also attended by Circle Secretaries of all three executive associations of Bihar i.e. AIBSNLEA, AIGETOA & SNEA (I). It was observed in the meeting that Telecom facilities are deteriorating in Patna and the SSA management has completely failed to respond to the demand of situation for improvement of the services.

The associations tried its best to awaken the SSA management towards issues faced by executives for improvement of the service. But the adamant and cold shoulder attitude of management to address the issues/problems to improve the services has shaken our faith. The services of BSNL earn bread and butter for all of us, so we can't be a mute spectator and allow the situation to derail beyond control. Hence, the Joint forum of all three Executive Associations [AIBSNLEA+AIGETOA+SNEA(I)] of Bihar has decided to serve the agitational notice to resolve the following demands to improve the services of BSNL and protect the rights of executives in the interest of the departments. The demands are:

1. *Immediate restoration of Service Mobile Numbers of all Executives of the SSA and adjustment of outstanding amount accumulated due to services used in the interest of BSNL.*
2. *Start of special initiatives to increase the business through wide publicity, marketing activities, arranging Mela etc. of recently launched scheme of BSNL e.g. "Free Night Calling", "Free National Roaming", "Upcoming National MNP facility" etc.*
3. *Immediate availability of store & resources required for day-to-day maintain the telecom facilities in the SSA especially considering the upcoming rainy season.*
4. *Immediate availability of labour through tender/agencies for maintenance works in the SSA.*
5. *The process of filing FIR to be done by Legal Cell of the SSA concerned instead of the field SDE for cut of UG/OF Cable etc on the basis of written complaint given by the field SDE concerned .*
6. *The withdrawal of order issued for the decentralisation of commercial works to field SDEs. It should be carried out as previously in the interest of BSNL.*
7. *The resolution of EPF issue of BSNL recruited employees of PTD before implementation of ERP in Bihar Circle. The EPF issue is lingering due to some silly delay on the part of BSNL to submit the revised statement of the employees to the EPF Authority in Patna etc.*
