We regret to mention here that in spite of our request vide above referred letter, the ETR management is not serious about existing volatile situation of sub-region ETR Bihar. The issues raised in the referred letter are of significant nature and transfer of Shri Sujit Kumar Gupta DGM ETR is one of the prime demands.

The Circle Secretaries of all Associations/Unions of Executives & Non-Executives under the banner of Forum of BSNL Bihar met to the GMM ETR on 13-5-2015 to resolve the crisis in the interest of BSNL Bihar, a home state of our Hon'ble MoC, Govt of India to avoid deterioration of telecom service. But the ETR Management failed to take cognizance of the issues even after passage of more than a fortnight and our all efforts in this direction to settle the crisis amicably.


A general body meeting of all executives of Sub-region ETR Bihar held today (18.05.2015) and it was unanimously decided to serve the notice for agitation program to resolve the issue.


So, we are compelled to serve the notice for organizational agitation program for immediate transfer of Shri Sujit Kumar Gupta, DGM ETR Patna in the interest of service. The organizational agitation activities will be as follows:


1. 22nd May'2015 Onwards: Start of Day Long Mass Dharna by all Executives of ETR Bihar
2. 25th May'2015 Onwards: Start of Mass Leave by all Executives of Sub-region, ETR Bihar.

The above agitation activities will continue till resolution of our demand for transfer of Sri S.K. Gupta DGM ETR Patna. We hope that the ETR management will wake up and take necessary action even at this belated stage in the larger interest of the department. Otherwise the entire responsibility for the break of industrial peace in the organization will be of CGM ETR, Kolkata & GMM ETR Patna.
