
The undersigned was appointed as the Chief Returning Officer for conducting 1st membership verification through secret ballot for electing majority representative Association (s) of Executives vide order no.BSNL/5-1/SR/2016 dated 14.06.2016. The polling was conducted on 07.12.2016 throughout the country in a peaceful manner.

2. The counting of votes was done on 09.12.2016. On the basis of information received from Returning Officer of all the circles, consolidated information related to votes polled and secured by all the 10 (Ten) participating Associations is furnished in the enclosed Annexure. Accordingly it is declared that following two Associations have emerged as 1st & 2nd largest in the 1st Membership Verification of Executives Associations:

- i) SNEA stands First by virtue of securing 20128 votes, i.e. 45.32% of total votes
- ii) AIBSNLEA stands Second by virtue of securing 18438 votes, i.e. 41.52% of total votes

3. As informed by SR Cell of BSNL CO, this result of Membership Verification of Executives' Associations is subject to the outcome of following Court cases pending before the various Courts.
