In pursuance with Time Bound Executive Promotion Policy, issued by the BSNL Corporate Office, New Delhi, vide letter Nos: (1) 400-31/2004-Pers/308 dated 18.01.2007,(2) 400-29/2007-Pers.I dated 30.05.2007, and subsequent guidelines/ clarification issued time to time, approval of the Chief General Manager Telecom, Bihar Circle, Patna is hereby conveyed for placing the following Executives in the upgraded 2<sup>nd</sup> IDA Pay Scale noted against each with effect from the date mentioned therein.

\*Note: As per the report received from the unit concerned, the executive at Sl. No. 1 has cleared Mandatory Training beyond stipulated period of two years i.e. on 28.09.2012 for his earlier up-gradation ( E1-E2), hence 2nd increment may be granted notionally & on actual basis from the date of passing of mandatory training. Over payment, if any, may be recovered.

The pay up-gradation of the Executives will be under the following terms and conditions.

The pay of the Executives who have been placed in the upgraded scale shall be fixed as per guide line of Time Bound Executive Promotion Policy by the BSNL Corporate Office, New Delhi.

There will be no change in the substantive status, designation, duties and responsibilities of the Executives unless any change is ordered in any specific context.

Before fixation of pay in the upgraded scale the controlling authorities/DDO will verify from the Service Book afresh the date on which the IDA scale was last fixed and the date of completion of five years of continuous service of above executives from their respective service book and ensure that the executive basic pay has crossed/touched the lowest of next higher IDA Scale.

The Time Bound up-gradation of IDA pay scale of the Executives under the policy is personal to the executive concerned. So no claim whatsoever can be made by comparison on grounds of Seniority, Class, Community, Cadre, Stream etc. Further except as provided in instant guidelines no claim will be on account of any of the other provisions of FR, SR at the context of pay scales, pay fixation, substantive status etc.

Any up-gradation due to the Executive on or before 01.10.2004 based on the earlier time bound policies; such up-gradation will be granted on the basis of options as one time relaxation if he/she is willing for such promotion and adjudged fit in accordance with concerned regulatory conditions. **OPTIONS ONCE EXERCISED SHALL BE FINAL.** The subsequent eligibility for IDA Pay scale up-gradation of such executives will be governed by BSNL's Time Bound Up-gradation Scheme as provided in Para (1) (b) (3.2) of BSNL's order under reference.

The Executives whose pay is upgraded to next higher IDA Pay Scale will have to compulsory undergo **TWO WEEKS** of mandatory up-gradation training as prescribed for being eligible for drawal of 2<sup>nd</sup> increment in the upgraded IDA Scale within a period of 2 (Two) years from the date of issuance of time bound up-gradation order. The executive who fails to successfully complete the online up-gradation training will not be eligible for consideration of next IDA scale up-gradation even if he/she is due for up-gradation otherwise.

If any disciplinary/vigilance case is pending/contemplated or punishment if any is current against any of the executives who have been placed in the upgraded IDA scale, the same may be intimated to this office before implementation of this order for the particular Executive and no up-gradation may be granted without further instructions from this office.


Further if any omission/commission is found same may be intimated to this office for rectification.
