
The appointment is subject to the following terms & conditions:-

They will be eligible to earn their second increment only on successful completion of 6 weeks Phase – II training within two years.

6. If any Vigilance/Disciplinary case is pending/contemplated against the executives promoted above, they may not be given promotion and matter may be reported to this office for further necessary action.


