



In pursuance of CGM, BSNL, U. P (East) Telecom Circle, Lucknow letter no. Staff/M-7-6/IC/JTO/BSNL/2016/4 dated 30/07/2016, the competent authority of Bihar Telecom Circle, Patna is pleased to approve the Rule-8 one way (Outward) transfer in respect of Shri Sumant Singh (HRMS No-200902390), JTO O/o the GMTD, Chapra under Bihar Telecom Circle, Patna and accordingly relieved from the strength of Bihar Telecom Circle, Patna for reporting to AGM (Admin), O/o CGM, BSNL, UP (East) Telecom Circle, Lucknow, as per BSNL Rule-8 New transfer Policy notified on 07/05/2008 on the following terms & conditions.

1. He will not claim any TA/DA/TP/Joining Time.
2. His pay on transfer will be fixed as per existing rules.
3. His seniority on transfer will be fixed in the gradation list of the new unit as laid down in Rule-8 of BSNL's Employees Transfer Policy dated 7.5.2008.
4. His claim for the benefit of promotion, on having qualified in the departmental examination while working in the parent unit shall be permitted subject to the condition that a request to this effect is made by him within a period of six months of declaration of the result or finding a place in the select panel.
5. He should forego his entire claim in the parent unit, even if a permanent vacancy was available or become available because of the retrospective permanency of post or for any other reason he is/was entitled for confirmation against such post in his old unit/SSA.
6. He has never before availed of any change of transfer/mutual exchange within preceding five years.
7. He can not claim for a posting in any particular station of the new SSA/circle.
8. He is eligible for confirmation, only according to his position in the gradation list of the new unit.
9. All terms and conditions as laid down in the BSNL's employees Transfer Policy notified vide letter no. 6-1/2007-Restg. Dated 07/05/2008 as amended from time to time.
