

The appointment is subject to the following terms & conditions:-

1. The appointment is provisional and purely on temporary basis and subject to the terms and conditions laid down in Recruitment Rules 2014 of JTO (T) in BSNL.
2. The appointee will be on probation for a period of 2 years and if during this period their work and/ or conduct is found to be unsatisfactory, their services will be terminated forthwith without any notice.  
Seniority of the appointees shall be fixed according to the Rules and orders in force. Other conditions of service will be governed by the relevant rules and orders in force from time to time. They will be eligible to earn their second increment only on successful completion of 6 weeks Phase – II training within two years.
4. This appointment carries with the liability to serve in any part of Bihar Telecom Circle in the normal course and in any part of India in the interest of service.
5. A Junior Telecom Officer, who has not completed the age of forty (40) years, if so required, will be liable to serve in the Territorial Army subject to the provisions of section 6A of the Territorial Army's Act 1948 (58 of 1948) and rules made there under.
6. Other conditions of service are governed by the relevant order in force from time to time. Date of joining as JTO may be intimated immediately to all concerned.
7. If any Vigilance/Disciplinary case is pending/contemplated against the executives promoted above, they may not be given promotion and matter may be reported to this office for further necessary action.
8. Posting has been done in the interest of service.
